- \*Day time minimum spend \$3000
- \$200 deposit is required to confirm your function, this will not be accessed unless you cancel within 14days,
- Please follow all COVD directions by Covid Marshalls or government regulators.
- All effort will be made to reschedule any function affected by COVID directions.
- Public holidays incur an additional \$10 per head per adult surcharge, no further surcharge apply.
- It is your responsibility to advise us of dietary requirements / allergies prior to your event.
- Please note; we do not accepted vehicles carrying a liquor licence. We will refuse entry to any group that contravenes our liquor licensing obligations (this translates to please don't arrive drunk or we will refuse entry).
- We ask that you respect other diners' personal space and comfort.
- You will lose any monies paid / held if we refuse entry / service due to intoxication.
- No food or drink is to be brought onto the premises; any breach will incur a \$25 corkage penalty per beverage.
- · We are not a picnic facility.
- While we endeavour to match all seating requests, sometimes it is necessary to move a booking to accommodate weather conditions or other guests' comfort.
- Shoes are to be worn at all times.
- · Any booking that becomes a surprise wedding will incur a venue hire fee.
- Parental Responsibility please note while we are child friendly, we are not a child-minding service. You will be financially liable for any damage to our property that any child or adult causes. For their safety, children are to remain within sight of parents at all times.
